## **GOVERNMENT-TO-GOVERNMENT EXCHANGES**



The Chief Executive, Mr John Lee, met with the visiting Deputy Prime Minister and Coordinating Minister for Economic Policies of Singapore, Mr Heng Swee Keat, in April, stressing further collaborations with Singapore on all fronts, especially in the areas of green and digital economies and emerging industries. Mr Lee also highlighted the upgrading of China-Singapore relations to an All Round High Quality Future Oriented Partnership last year, adding that Hong Kong as a "super connector" and "super value-adder" will continue to promote mutually beneficial economic growth between China and Singapore.

# Hong Kong and Laos connected in direct flights

Hong Kong Airlines launched the inaugural direct flight from Hong Kong to Vientiane, the capital of Laos on April 27. The direct flight was part of the airliner's efforts to strengthen connectivity along the Belt and Road countries. The flight will depart Hong Kong International Airport at 2.55 pm on Saturdays, arriving at the Wattay International Airport in Vientiane at 4.20 pm (Laos time). The return flight will depart Vientiane at 5.20 pm also on Saturdays, landing in Hong Kong at 8.40 pm (HK time) \*.

# **Judicial exchanges**

Hong Kong and Singapore attained a milestone in judicial exchanges in March, as the High Court of Hong Kong inked an MoU with the Family Justice Courts of Singapore to promote the efficient administration of the family justice systems in the two jurisdictions. The MoU covers knowledge-sharing in family law, concerning case management, technology integration, judicial training, procedural rules, use of mediation, etc.





### **Cultural exchanges**

The West Kowloon Cultural District Authority (WKCDA) made another leap in its inaugural Hong Kong International Cultural Summit in March, having signed MoUs with over 20 leading arts and cultural institutions from 11 countries, covering exhibition co-production and touring, conservation, scientific research, educational and exchange programmes. Among the signatories is Singapore's Asian Film Archive, which is focused on the preservation of the rich film heritage of Singapore and Asian Cinema.

# Innovation and technology exchanges





Located at the Lok Ma Chau Loop in Hong Kong, the Hong Kong-Shenzhen Innovation and Technology Park (HSITP) will be developed as a key base for cooperation in scientific research, and higher education, cultural and creative industries. In April it signed MoUs with some 60 world-class enterprises, academia and research institutes to forge partnerships. Among them is Singapore's Orbit Ventures. With its strategic location, HSITP will form part of a cross-border 387-hectare Shenzhen-Hong Kong Science and Technology Innovation Co-operation Zone as a key innovation and technology hub.
